## NOTICE TO INTENDING EXHIBITORS

Entries will only be received on the "Application to Enter" Form enclosed with this Schedule. Entries submitted other than on the correct form will be returned to the Exhibitor and, unless all requirements are complied with and the forms returned to the office by 4.30pm on the "Application to Enter" Form closing date as shown in the Schedule, they will not be considered.

### PRIVACY STATEMENT

You can be assured that the privacy of your personal information is of the utmost importance to us. The information provided by you in any application for membership or application to enter is used by the Royal National Agricultural and Industrial Association of Queensland (RNA) to offer member services or to organise and conduct competitions at the Royal Queensland Show. By applying for membership or entering such competitions you consent to provide such details as your name, address and Exhibit details. Competition information may be made available to the media and included in RNA publications.

Your information will not be disclosed without your consent for any other purpose unless required by the law. You may request access to your information and request that our records of that information be corrected by contacting our Privacy Officer (07) 3852 1831 or by writing to the RNA, Locked Bag 1010, ALBION QLD 4010.

**The attention of Exhibitors is drawn to the following extracts from the By-Laws.**

### DISEASE OR DANGER

- 58 Should there be any reason to suspect that any Exhibit is either diseased or dangerous, or objectionable, the Council through its Officials, reserves the rights of removing the same from or refusing its admittance to the Royal Queensland Show.
- 59 An Exhibitor who detects or suspects any illness amongst any of his entries whilst the animals are at the Showgrounds must:
- (a) Report this fact immediately to the Superintendent responsible for that particular section;
  - (b) Ensure that the animal/s is/are contained within its/their accommodation area/s unless advised otherwise by the Superintendent or the Association's Veterinary Surgeon; and
  - (c) Where feasible to do so, contain soiled bedding from the animal/s within its/their accommodation area.
- 60 Council may at its discretion require to have any biological tests carried out on any animal exhibited at the Royal Queensland Show or to have materials collected from such animals in order to have tests carried out, after such animals arrive at the Showgrounds.
- 61 If in the opinion of a Council Steward of a Section, an Exhibit in such Section requires Veterinary treatment then if the Exhibitor cannot be contacted immediately, the Council Stewards may instruct a Veterinary Surgeon to treat such Exhibit and the costs of such Veterinary Surgeon shall be paid by the Exhibitor to the Association. The Association shall not be in any way liable to an Exhibitor for any damage to or injury to such Exhibit.
- 62 Where, in the opinion of the Association, an Exhibit, being an animal, should be destroyed or removed from the Showgrounds, the Association's Veterinary Surgeon or the Association may destroy or remove the Exhibit from the Showgrounds, or both. Alternatively, the Association may require the Exhibitor to destroy or remove the Exhibit from the Showgrounds, or both. Any costs incurred by the Association pursuant to this By-Law must be reimbursed by the Exhibitor.
- 63 The Association shall not be responsible for any loss or damage caused (inter alia) through disease or infection howsoever arising.

## UNETHICAL CONDUCT

- 105 The Exhibitor, the Owner or any person in charge of an animal Exhibit shall not engage in unethical conduct. The Exhibitor, the Owner and any person in charge of an animal to which unethical conduct relates are deemed to have acted in breach of this By-Law, whether or not having been knowingly concerned in the unethical conduct. The Council or relevant Sectional Committee shall decide whether or not any conduct constitutes unethical conduct but without in any way restricting the meaning of that expression, unethical conduct may include the presentation as an Exhibit for judging:
- (a) of an animal other than in its natural conformation after normal feeding and grooming, except as otherwise provided either expressly or by necessary implication in the regulation or in the definition of a class in which the animal is entered;
  - (b) of any animal having undergone any operation or procedure materially altering the structure or natural conformation of any part of its body, whether by the introduction of any substance or thing subcutaneously, or by any surgery, or by the administration of any substance or chemical or by the attachment of any object or thing;
  - (c) of an animal having undergone any operation or procedure that changes by exaggeration, minimisation or otherwise in natural conformation or physical constitution or appearance;
  - (d) of an inanimate object, that is created, constituted, formed or includes goods, substances or things not normally found in objects of like nature;
  - (e) that is not the animal or the object or thing entered for the Class to be judged;
  - (f) in breach of the Regulation.
- 106 An Exhibitor, or person in charge, of an animate Exhibit must:
- (a) use all reasonable steps to ensure that the Exhibit is housed and cared for in accordance with the Association's current animal welfare policy;
  - (b) obey any direction from a member of the Association's Council, or from any other official of the Association, relating to the care and welfare of that or any other Exhibit;
  - (c) if called upon to do so, surrender the Exhibit to the Association, in circumstances where in the reasonable opinion of the Association's Veterinarian, the Exhibit is in need of urgent veterinary attention.
- 107 An Exhibitor must not use, or have in his possession, any electric or electronic apparatus or any improper contrivance capable of affecting the performance of an Exhibit.
- ### EXHIBIT UNWORTHY OF AWARD
- 108 An Exhibit shall not receive an award if in the opinion of the Judge it is unworthy of such award.
- ### PROHIBITED SUBSTANCES
- 122 A Person must not administer a Prohibited Substance or cause one to be administered to an Exhibit, except as permitted by the By-Laws or the Regulations.
- 123 The Exhibitor, the Owner and Attendant of any Exhibit to which a Prohibited Substance has been administered is in breach of the By-Laws unless the Prohibited Substance is permitted by the By-Laws or Regulations to be administered.
- 124 An Exhibit to which a Prohibited Substance has been administered in breach of the By-Laws must be removed from the Showground upon demand by the Association.

- 125 The Association may in its discretion and at any time, cause an examination to be made of an Exhibit by a Veterinary Surgeon who, in the course of such examination, may:
- take such samples (including, without limitation, urine, blood, saliva and faeces) from such Exhibit as he considers necessary or advisable;
  - have such samples tested by such methods and procedures as he considers appropriate; and
  - examine the Exhibit for desensitised limbs.
- 126 Any Exhibit found by a Veterinary Surgeon to have a limb (or part thereof) desensitised is deemed to have had administered to it a Prohibited Substance in breach of the By-Laws.
- 127 Where, prior to an event, a Veterinary Surgeon is of the opinion that a Prohibited Substance may have been administered to an Exhibit, the Veterinary Surgeon may require that the Exhibit be examined prior to competing in that event.
- 128 The Association may publish procedures relating to the examination of Exhibits. Such procedures are binding on Exhibitors, Owners and Attendants.
- 129 Any Exhibit which has been brought to the Showgrounds and is found to have had administered to it any prohibited substance as defined above may, without prejudice to any other action which may be taken in respect of the matter, be debarred by the Council Stewards from competing in any event for which it may have been entered.
- 130 The Exhibitor, the Owner and any person in charge of an animal to which a prohibited substance has been administered, by any person, and whether or not with the knowledge of the Exhibitor, Owner or person in charge, is deemed to have acted in breach of this By-Law.
- 130A No person shall have in his possession on the Showgrounds any prohibited substance, syringe, needle or other instrument which could be used to administer a prohibited substance to an animal Exhibit, unless that person shall have obtained the permission of the Association to be in such possession, or satisfies the Association that such possession is for lawful and proper use.
- 131 The Association and any Council Steward servant or agent of the Association shall not be liable to an Exhibitor for the death of or for injury damage or infection which may be sustained by his Exhibit occasioned by or arising out of any act or omission of any Council Steward, servant or agent of the Association during the course of the testing of the Exhibit whether due to the negligence of any such Council Steward, servant or agent or otherwise.

#### PROHIBITED SUBSTANCES - DEFINITION

'Prohibited Substance' means any substance originating externally to an animal (and whether or not endogenous to the animal) capable of affecting the performance or behaviour of the animal by its action upon:

- the central or peripheral nervous system;
- the cardiovascular system;
- the respiratory system;
- the alimentary digestive system;
- the musculo-skeletal system;
- the urogenital system; or
- the endocrine system.

and includes without limitation:

- analgesics;
- anti-histamines;
- anti-inflammatory agents;
- blood anti-coagulants;
- diuretics;
- hormones and their synthetic counterparts;

- cortico-steroids;
- anabolic steroids;
- local anaesthetics;
- muscle relaxants;
- tranquillisers;
- vitamins;
- antibiotics;
- stimulants;
- glues and bleaches.

#### PRIZE AWARDS

The Prize Ribbons, affixed to Exhibits, shall be distinguished by the following colours, viz:-

Special Prizes	Pale Blue

For Group Classes - Pink and Blue, Pink and Red, Pink and White, Pink and Yellow, for First, Second, Third and Fourth respectively. Ribbons will only be attached to Exhibits in the Horse, Cattle, Sheep, Pig, Goat and Dog Sections.

#### DPI REGULATIONS

##### Major Changes

Livestock from Queensland require a Queensland Travel Permit and a Move Easy Waybill or a NVD/Waybill. Livestock from NSW entering Queensland via Tweed Heads or Mt Lindsay Border Crossings require a Queensland Travel Permit and a Move Easy Waybill or a NVD/Waybill. Livestock from NSW entering Queensland from Killarney west require a Queensland Certificate of Health/Waybill.

##### National Livestock Identification System

- It is mandatory for NLIS animal identification for all goats moving off the property of consignment.

NLIS has two types of tags – 'breeder' and 'post-breeder' tags.

- A 'breeder' tag is applied to stock on their property of birth.
- A 'post-breeder' tag is applied to untagged goats that are not bred on the property of consignment.

**NSW/Qld Border Crossings from Killarney west are unstaffed (see 4 for details).**

##### STOCK GENERAL

- NLIS – All sheep goats on the grounds must be identified in an approved manner before leaving the property of origin.
- Only tick free stock will be allowed entry to the grounds.
- All Queensland horses, cattle, sheep, goats, donkeys, angoras, alpacas, deer, camels and mules must be accompanied by a DPI&F Travel Permit endorsed with treatments performed (if necessary) and an owner Waybill.
- QUEENSLAND STOCK NOT ACCOMPANIED BY A DPI&F TRAVEL PERMIT AND FULLY COMPLETED OWNER WAYBILL WILL BE REFUSED ENTRY TO THE GROUNDS.**

## 5. DAIRY GOATS FROM AND RETURNING TO NEW SOUTH WALES:

### **Tweed Heads & Mt Lindsay crossings. Stock crossing at these crossings require:**

- Queensland Travel Permit
- Queensland Certificate of Health/Waybill - should be obtained from your local Department or Livestock Health & Pest Authority prior to the movement commencing.
- Owner Declaration – these will be sent out when nominations are confirmed.

### **Other Border Crossings from Killarney west have closed. Stock crossing at these crossings require:**

- Queensland Certificate of Health/Waybill - should be obtained from your local Department or Livestock Health & Pest Authority prior to the movement commencing.
- Owner Declaration – these will be sent out when nominations are confirmed.

\* Stock must travel direct to the Exhibition Grounds. A Queensland Travel Permit will be issued at the RNA Grounds for the return journey.

Exhibitors should be aware that NSW/Queensland Border Crossings at Tweed Heads and Mt Lindsay no longer operate 24 hours. They now operate from 5.00 am to 9.00 pm. Exhibitors should make prior arrangements with the respective Border Crossing before commencing their journey. Arrangements for the return journey should be made at the RNA Stock Office.

## 6. TICK TREATMENTS (EX TICK INFECTED ZONES)

- Dairy goats from the Tick Infected zones in Queensland – Permit and "Move Easy" waybill required.
- Dairy goats must be **free of Cattle Ticks**.
- It is the responsibility of dairy goat owners to ensure their charges are tick free. Dairy goats, which have had any risk of exposure to cattle tick, should be treated by the owner with an approved tickicide 3-7 days prior to entry. The tickicide used and date administered should be provided to the local Inspector of Stock when obtaining your Travel Permit.
- All dairy goats must be presented to the standard expected at a Royal National Show. Dairy goats, which do not come up to standard, may be refused entry or asked to leave the grounds. Dairy goats from the Infected Zone staying at the RNA grounds for longer than 5 days may be inspected at the grounds. Random inspections will be conducted on other dairy goats from Tick Infected Zones.

## DAIRY GOATS

Apart from general and tick control conditions the following conditions will also apply:

### **CAPRINE RETRO VIRUS (CRV)**

(a) Animals are from a completely accredited free (AF) herd under a recognised CRV Accreditation scheme

### **JOHNE'S DISEASE – for both Bovine Johne's disease (BJD) and Ovine Johne's disease (OJD).**

Goats must not be introduced unless they comply with the conditions for animals to enter Queensland:

1. They are from a Check Tested (negative) (CT(n)), Monitored Negative 1 (MN1) or equivalent or better status herd established under the Market Assurance Program (MAP) for goats; or
2. Other – The herd history to be provided to RNA at the time of nomination. Each will be assessed by the RNA Animal Health Committee.

## CERTIFICATES

The Caprine Retro Virus and Johne's Disease status of the herd must be endorsed on the Queensland DPI&F Travel Permit and in the case of Interstate Stock it should also be endorsed on the Certificate of Health/Waybill.

## **REGULATIONS APPLYING TO DAIRY GOATS**

1. No drug, hormone or tranquilizer shall be administered to any animal Exhibit except by permission of the Council Stewards or under the direction of the Association's Veterinary Surgeon who shall advise the Council Stewards if in his opinion such drug, hormone or tranquilizer is likely to have any effect upon the animal which would be material to its chance of being awarded a prize and in such case the Council Stewards may debar the animal from competing.

The Council Stewards may at any time direct the Association's Veterinary Surgeons to take a sample or skin scraping of blood, saliva, urine, discharge, exudation or any other sample from an Exhibit for testing.

2. Dairy Goats entered in this section must be registered in the name of the Exhibitor as owner, in a herd book recognized by the Association or recorded in the appendix register of the recording body.
3. Photocopies of Herd Book Registration Certificates for each animal and CRV Accreditation Certificates must be lodged with entry forms.
4. Doe entered in milk can be transferred to the dry class, if she has not kidded prior to judging day, or vice versa. Dairy Goats in or transferred to dry classes may be required to be stripped out under supervision at 9.00am on judging day. Only Dairy Goats entered in competitive classes and kids not more than seven days old will be permitted onto the RNA Showgrounds.
5. The age of all Dairy Goats to be calculated from the birth date shown on the kid's record and/or registration form up to 30 June 2011.
6. All Dairy Goats shall be fed and attended to by the Exhibitors while the Dairy Goats remain on the Showgrounds.
7. The Grand Parade will be led by the Supreme Champion Dairy Doe followed by its breed. The remainder of the breeds will follow in order of numerical strength.
8. No Persons under the age of 10 years is permitted in the main ring during the Grand Parade. All handlers must be capable of controlling any animal in their care.
9. All persons leading stock during judging or the parades must wear a grey or white dustcoat. Stud identification names must not be displayed on clothing or equipment during judging.
10. There will be no restriction in the number of entries in any class with the exception of the doe/kid under twelve months classes which may be restricted by the Council Stewards, should an excess of entries warrant it.
11. It is the responsibility of each Exhibitor to ensure that the leaders of their stock in judging rings and parades are capable of exercising control over the animals in their care.
12. The Exhibitor irrevocably consents to the RNA publishing or reproducing in any manner whatsoever any particulars or information in relation to their Exhibits; the publication or reproduction may be in a printed form or visual image through electronic means and/or on the internet.

## WORKPLACE HEALTH AND SAFETY ACT 1995

1. The RNA Showgrounds is a designated Workplace within the meaning of the Act and Exhibitors/competitors are required to ensure that they and all persons under their direction or control, including their contractors or sub-contractors, comply with all requirements of the Act and the RNA holds each Exhibitor responsible to discharge its obligations to provide and maintain a safe place and system of work during occupation by the Exhibitor/competitor of any area of the RNA Showgrounds.
2. Each Exhibitor/competitor will assess the risk to themselves, staff, volunteers, family, other Exhibitors, RNA staff, show visitors and any person foreseeably affected by the presentation of their Exhibit.
3. Risks identified by Exhibitors/competitors will be eliminated or controlled by the Exhibitor/competitor and particular attention will be paid to ensuring public safety and safety of other Exhibitors/competitors.
4. Exhibits will only be led and handled by competent persons whose experience is known to the Exhibitor/competitor.
5. A **"No Smoking Policy"** will be strictly adhered to and policed by Exhibitors/competitors and Exhibitors/competitors are advised that the use of Primus stoves, any heating or lighting appliances of a like character, or any naked light, is strictly **prohibited** in the horse stalls or pavilions.
6. Any Exhibitors/competitors intending to bring electrical equipment to the RNA Showgrounds will be required to ensure that such equipment is fitted with residual current protection and that all electrical leads, tools and appliances have been inspected by a licensed electrical contractor and currently tagged. The use of double adaptors is **prohibited** and all power boards must be tested and tagged.
7. All Exhibitors/competitors will comply with the requirements of the Act and its Regulations and Standards in every other respect.

This is essential for the safety of all Exhibitors/competitors and the general public. The Act imposes very severe penalties in the event of non-compliance with its provisions.

Any Exhibitors/competitors who do not comply will not be allowed to Exhibit at the Brisbane Exhibition.

## INSPECTOR OF EXHIBITS

The Association shall ask the Dairy Goat Society to appoint an Inspector or Inspectors to examine Exhibits in all Dairy Goat Classes for Exhibition. Inspectors are required to submit a written report to the Council Stewards giving details of any animals which bear Tattoos or Electronic ID which are not consistent with the details printed in the Show Catalogue or which they consider to be below Royal Show standard. Any animal which is then rejected by the Council Steward shall not be exhibited and arrangements may be made for it to be removed from the RNA Showgrounds or segregated.

## DAIRY GOAT PAVILION COMPETITION

The purpose of this Competition is to encourage tidiness and cleanliness in the Dairy Goat Pavilion and to give recognition to an Exhibitor who presents his/her stock attractively to the public. Exhibitors will be judged on a total of 100 points. Subject to the foregoing, the judge will take into account the grooming and cleanliness of goats, bedding, tidiness of stalls, laneways and equipment. Association's banner and a Certificate of Merit will be awarded to the winning Exhibitor.

Judging will commence on the first Saturday of the Show and will conclude on the final Thursday of the Show, with the exception of Judging Day.

## YOUNG JUDGES' COMPETITION

A Young Judges' Competition will be conducted on the No. 2 Oval on Sunday 14 August 2011 at 3.30pm. The breed to be selected by the Judge. Entries will be accepted at the location on the day of competition. Further particulars and schedules are available on application.

## ARRIVAL OF EXHIBITS

All Dairy Goats must be on the grounds no later than 5.00pm on Friday 12 August 2011.

All Dairy Goats must on arrival at the RNA Showgrounds be penned as directed by the Steward-in-Charge. No alteration will be made to the prepared penning plan without the authority of the Council Steward-in-Charge. Breach of this Regulation may result in disqualification.

## PRE-JUDGING

All goats must be milked out under supervision at 7.00pm on Sunday 14 August 2011. Exhibitors may milk out again during the night if they so desire.

## JUDGING

Dairy Goats judging will be judged at 9.00am Monday 15 August 2011. All animals will remain on exhibition on that day and until 3.00pm on Friday 19 August 2011.

Any animal, which in the opinion of the Council Stewards, is not in a fit state to be exhibited, may be rejected by them and debarred from competing in the class or classes for which it is entered. Any animal rejected must be removed from the Showgrounds as soon as the Exhibitor is notified.

In the event of the Judge deciding that the Exhibits in any class or Championship are not worthy of a prize, no prize shall be awarded. All animals must be clearly tattooed or EID prior to the Exhibition. At the completion of the judging of the full Udders in Classes 14 and 15, all-in-milk does must be milked out in preparation for the judging of the Breeds Champion and Supreme Champion Dairy Doe.

**The Senior Champion Doe shall be selected from First Prize Winners in Classes 2 years old and over. The Junior Champion Doe shall be selected from First Prize Winners in Classes under two years. After selecting the Champion the Judge will be required to select an animal for Reserve, which will take the place of the Champion in the event of the latter being disqualified for any cause; the Reserve shall be selected from the remaining First Prize animals, together with the Second Prize of the Class which furnished the Champion.**

Champions will be awarded after the completion of general breed classes.

## VETERINARY SERVICES

The Association's Council is pleased to advise that for the forthcoming Royal Queensland Show arrangements have again been made for veterinary services to be available on a 24 hour basis commencing on Saturday 30 July 2011 through until Saturday 20 August 2011.

The official veterinary surgeons are permitted to charge their normal consultation fees plus an hourly rate for extended services. In addition Exhibitors will be required to pay the cost of all drugs used. Exhibitors will be responsible for the payment of all monies owing to the veterinary surgeons.

## ACCEPTANCE OF ENTRIES

The attention of Exhibitors is drawn to the fact that entries are accepted subject to the Royal National Agricultural and Industrial Association of Queensland Act 1971, and to the Constitution Rules and By-Laws of the Association, in addition to the Regulations which appear in this Schedule.

Copies of the RNA Constitution, Rules and By-Laws may be obtained upon application to the Entries Department.

1. All animals competing must be registered in an approved Herd Book recognized by the Association or recorded in the Appendix. All animals in the milking class must be penned by 5.00pm on Friday 12 August 2011
2. All does must be milked out under supervision at 6.00pm on Saturday 13 August 2011.
3. Any doe whose yield of milk at the milk - out is less than 66.66% of her yield at the final milking of the test shall be ineligible for a prize.
4. No doe will be eligible for a prize unless she produces at least 2kg of milk in 24 hours or if the assessed average butterfat content is less than 3.2% and the protein content is less than 2.8%. Dairy Goats disqualified from the milking competition are ineligible for a prize in the butterfat competition.

5. If necessary the competition may be run in divisions. The milking of goats must be completed within 20 minutes of the start of the Division. Goats must be milked in the same order at each milking. No Dairy Goat is permitted to take part in a test unless she has kidded seven clear days before commencement of the stripout preceding the milking test.
